- ü Section 21 (c): Impeding or Diverting the Flow of Water of a Watercourse


The Integrated Water Use License Application will be accompanied by a Technical Report which will detail all water uses, and propose suitable monitoring programmes and mitigation measures where applicable.

The construction of facilities for any purpose in the 1:10 year flood line of a river or stream, or within 32 m from the bank of a river or stream where the flood line is unknown, excluding purposes associated with existing residential use, but including bridges.
