

and powerline deviation projects and the environmental authorisation process.

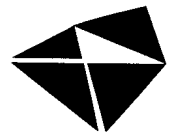

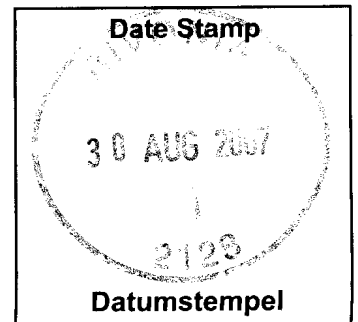
