RE: IN RESPONSE TO THE BACKGROUND INFORMATION DOCUMENT FOR THE AGGENEIS - PAULPUTS 400KV TRANSMISSION POWERLINE AND UPGRADE OF SUBSTATIONS, NORTHERN CAPE PROVINCE JULY 2016

Main Street 957 (RF) Proprietary Limited (the "Project Company"), for the Aggeneys Solar Energy Facility (the "Project"), received a copy of the background information document ("BID") and invitation to register and comment for the proposed Aggeneis - Paulputs 400kV Transmission Powerline on 16 August 2016 via email.

The Project is located ~6km north-east of Aggeneys town on portion 1 of the Farm Aroams 57 RD. The Project was awarded Preferred Bidder status under Round Four of the Renewable Energy Independent Power Producers Procurement Programme (REIPPPP) being implemented by the Department of Energy.

After reviewing the BID it was confirmed that proposed Routes 1 and 2, traverse over the Project site (please refer to Annexure A). During engagements with Eskom regarding the Project, it was indicated that the EIA that had been completed for the new 220kV powerline avoided the Project. It was expected that upgrade EIA for the 400kV powerline route would follow this same route.

During the EIA and design phase of the Project, the Project Company has ensured that sufficient servitude areas associated with the Aggeneis/Gamsberg 66kV powerline and the Aggeneis/Paulputs 220kV powerline have been excluded from the Project site area. There has been no additional servitude considered for a new powerline on the Project site.

The Project Company therefore objects to the proposed Routes 1 and 2 unless the Project site is completely avoided. As the Project is a Preferred Bidder Project and Is targeted to commence with construction in the fourth quarter of 2016, there can be no adjustments to the Project site and therefore no new infrastructure can be permitted over the Project site.
