**RE: IN RESPONSE TO THE BACKGROUND INFORMATION DOCUMENT FOR THE AGGENEIS - PAULPUTS 400KV TRANSMISSION POWER LINE AND UPGRADE OF SUBSTATIONS, NORTHERN CAPE PROVINCE JULY 2016**

Ramizone (RF) Proprietary Limited (the "Project Company"), for the Konkoonsies II PV Solar Energy Facility (the "Project"), received a copy of the background information document ("BID") and invitation to register and comment for the proposed Aggeneis - Paulputs 400kV Transmission Power Line on 16 August 2016 via email.

The Project is located ~30km north-east of Pofadder town on portion 6 of the Farm Konkoonsies 91. The Project was awarded Preferred Bidder status under Round Four of the Renewable Energy Independent Power Producers Procurement Programme (REIPPPP) being implemented by the Department of Energy.

After reviewing the BID, it has been confirmed that all proposed route corridors traverse over the Project site (please refer to Annexure A). During the EIA and design phase of the Project, the Project Company ensured that sufficient servitude areas associated with existing Aggeneis/Paulputs 220kV powerline has been excluded from the Project site area.

During discussions with Eskom regarding the Project's grid connection, Eskom was advised by the Project Company that the Project was a Preferred Bidder Project and that the Project designs had been approved. The Project Company, however, agreed to reserve as much servitude area along the existing Aggeneis/Paulputs 220kV powerline for the proposed powerline (at this point it was a new 220kV powerline). The Project Company managed to reserve 35m in addition to the existing servitude of 47m, therefore a total of 82m has been reserved along the existing Eskom servitude.

The Project Company therefore objects to all of the proposed routes unless the Project site is completely avoided. As the Project is a Preferred Bidder Project and is targeted to commence with construction in the fourth quarter of 2016, there can be no further adjustments to the Project site.
