#### ADDENDUM TO THE PUBLIC PARTICIPATION REPORT

#### Introduction:

The meeting of 08 August 2007 resolved that stakeholders would be given an opportunity to review the Extended Study report before it is submitted to the Minister for consideration when deciding on the appeals for the section of the 765kV power line route near the Vredefort Dome World Heritage Site. After this meeting, the public consultation was continued as follows:

- More landowners were identified
- Farm visits were conducted to take panoramic photographs of various view sheds
- The Extended Study report was made available for comment
- A public meeting was held to explain the report and receive additional inputs from the stakeholders
- Minutes of the meeting were posted for confirmation

## Minutes and Comments and Response Report

The minutes of the meeting contained the responses that were given for the issues raised. There is no *Comment and Response Report* generated for this study as most of issues were addressed at the public meeting. Responses received from stakeholders were in the form of corrections or comments on the content of the minutes and these have been included in the minutes. **Copies of responses received are attached for information. ### **Concluding Remarks**

The appeals against the original RoD were mainly based on the extent of consultation done, especially for the western alignment choice in the area. The consultants consulted extensively with the stakeholders for the extended study that was initiated to address the appeals. The two public meetings held were well attended by the local landowners. Farm to farm visits were made over and above the normal method of informing stakeholders about the project. Though there are still different opinions about the recommended route, it is our belief that sufficient consultation has been done and stakeholders were afforded fair opportunity to express their views on the project. Unfortunately it has not been possible to satisfy every body in terms of the recommended route.

Margen Industrial Services as the lead consultant that was directly responsible for the Public Consultation Process strongly believe that the consultation done is sufficient to assist the minister to make a decision on the route recommended.
