Dear Mike,

In response to your queries below, I can provide the following:

Power lines are proposed in both the northern and southern corridor. There will be 3 power lines in the northern corridor and 2 power lines in the southern corridor. 5 power lines in total for the whole project. Approval is being sought for both corridors.

The corridors in question are approximately 2km wide (slight variations along the corridor).

For the northern corridor, the power lines will require a servitude of approximately 165m.

For the southern corridor, the power lines will require a servitude of approximately 110m.

Approval is being sought for the full 2km corridors, specifically so that there is reasonable space / room for flexibility when negotiating and pegging final power line alignment.

I trust this answers your questions accordingly.
