Our agreement with Eskom is that their lines would be no closer than 202.5m from our turbines and 52.5m from our substation. The 202.5m was at their request they felt they needed to reduce this to 170m I don't foresee it being a problem.

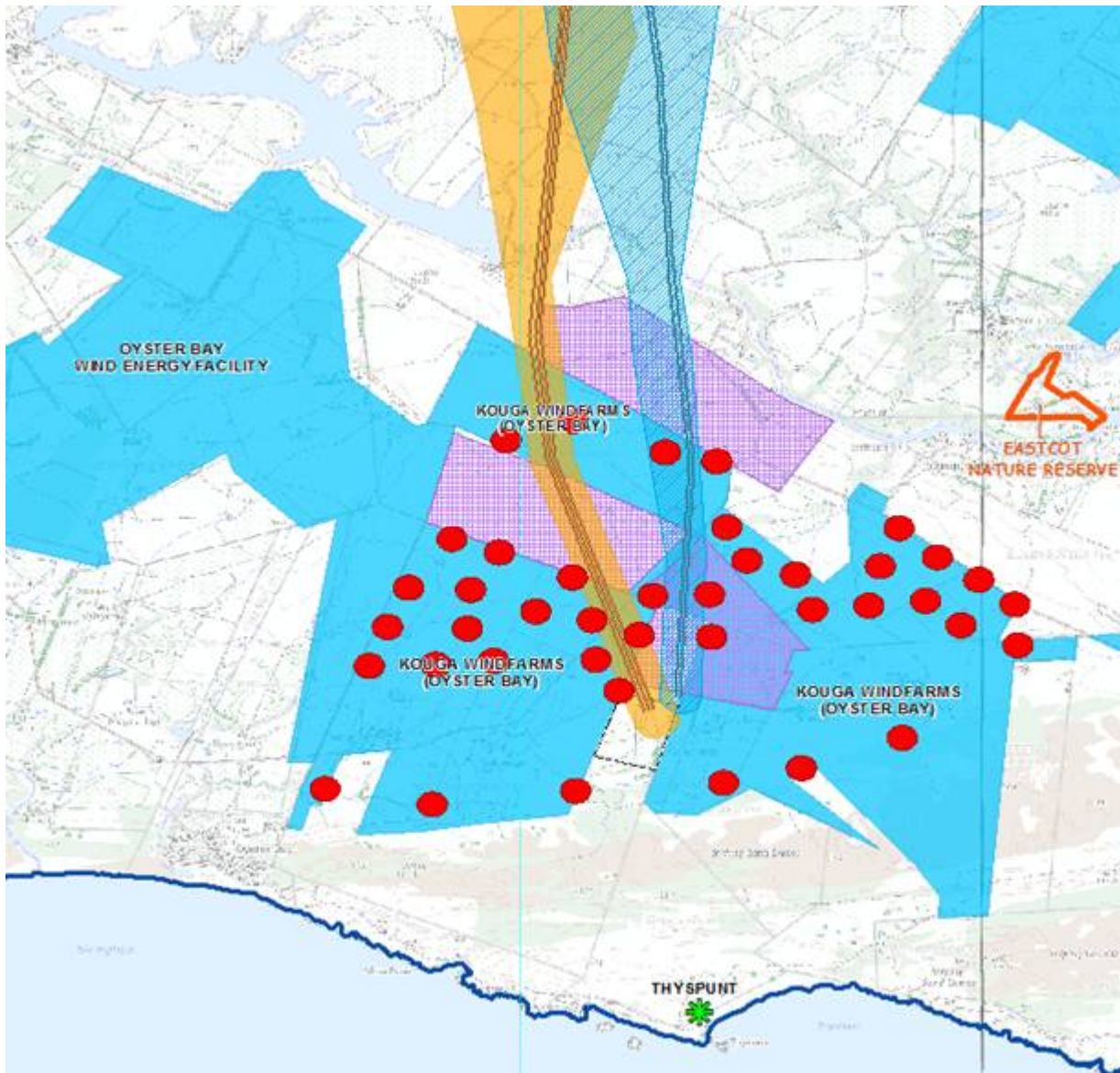
Hi Lance,
