

Applicant: Eskom Holdings SOC Ltd. Proposed Activity: Eskom Holdings SOC (Pty) Ltd, is proposing the development of two separate Lime Plants, one on the northern and one on the southern sections of the cooling towers at the Kriel Power Station (KPS), Mpumalanga Province, located entirely within the existing KPS property of Kriel Power Station, 65 IS. Project Location: The Kriel Power Station is situated approximately 43km south of eMalahleni (Witbank), 4km north east of the Matla Power Station and 8km west of the town Kriel. The proposed development falls within the jurisdiction of the eMalahleni Local Municipality and within the great Nkangala District Municipality. The affected properties adjacent to Kriel Power Station includes the following: Driefontein 69, Portions 1, 3, 8, 9, 13, 15, 17, 30, 31 and 32 Nooitgedacht 59, Portion 8 Vaalpan 68, Portions 3 and 9 Vlaklaagte 83, Portion 2 Onverwacht 70, Portions 9 and Remainder of Portion 10 Matla Power Station 141 Basic Assessment Process: In terms of Sections 24 and 24D of the National Environmental Management Act (No 107 of 1998), as read with Government Notice R324 – R327, as amended (2017), a Basic Assessment (BA) is required for this project. Savannah Environmental is undertaking the required BA and public participation process for the project.

Eskom (SOC) Ltd is proposing to upgrade the Lime Plant within the existing Kriel Power Station. The total area for the proposed new upgrades will be 1.96 ha combined for the two separate Lime Plants. Construction areas will include laydown areas and construction camps. Section 5 of the Basic Assessment report (BAR) states that no specialist studies will be undertaken for this EA application due to the proposed Lime Plant area being a brownfield site.

The assessment of heritage within the BAR concludes that although the proposed development area is underlain by Very Highly palaeontologically significant Vryheid Formation, but there is moderate possibility of uncovering fossil remains during construction because the site is heavily disturbed.

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit notes the assessment made in the BAR regarding the palaeontological significance of the development area however, due to the potential impacts on fossiliferous rocks a palaeontologist should review the assessment made in the BAR. Therefore, a Letter of exemption with a Fossil Chance Finds procedure and geological map must be written by a suitably qualified palaeontologist and submitted to SAHRA for comments. Prior to the submission of the BAR report to the competent authority. The Fossil Chance Finds procedure must form part of the EMPr for implementation by the ECO. The appointed palaeontologist must draft a fossil awareness programme for the construction team induction, as well as train the ECO in the identification of fossils that may occur within the region. The BAR does not provide an assessment of other types of heritage resources and the potential impacts that may occur to them, therefore SAHRA also requires an exemption letter exempting this application from undertaking a HIA must be submitted prior to the BAR submission to the competent authority. The letter must be drafted by a suitably qualified archaeologist, who will assess whether the buildings visible via satellite images and other heritage resources may be impacted by the development.

SAHRA will comment further once the letters are submitted to the case.
