## Labour official granted bail after being arrested for corruption

The Department of Labour official who was arrested by the Hawks Serious Corruption Unit members, has been granted bail last week at the Tzaneen Magistrate Court.

Collin Mpenyane (28) was arrested on charges of corruption.

"He was granted a R2000 bail and his case has been remanded to June 6 for further investigations," said Captain Maluleke, Hawks Spokesperson.

The suspect was arrested after attempting to bribe a business owner.

The complainant, owns a construction

company which is currently constructing a school in Xihoko Village at the Nwamitwa area, said Maluleke.

The suspect allegedly met with the complainant to discuss construction related

He demanded R19 000 from the complainant in order to be issued with a certificate of compliance.

The amount was later reduced to R4 000. The complainant reported the matter to the Hawks and a trap was set whereby the suspect was arrested immediately after receiving the money he had demanded from the complainant..

# No bail for murder suspects

The four suspects arrested for the killing of a woman whose body was found 10 days after her disappearance were denied bail when they appeared in the Giyani Magistrate Court

Daniel Dzambukeri (33), Christinah Mhlongo (53), Amos Chuma (48) and Solomon Mahumani (63) all residents of Nsavulani village near Giyani were remanded in police custody until Monday,

May 15 pending further investigations into the killing of Halayisani Precious

Hlongwane (26) from Hlomela village whose body was found in the village near Nsavulani after a joint search by the police and the community.

Police spokesperson, Lieutenant Colonel Moatshe Ngoepe said following Hlongwane's disappearance, members of the community went on a rampage burning four houses and damaging a car belonging to the people who were accused of being responsible for he disappearance.

Police investigations are continuing.

## Drugs worth R58 000 found at Mokgoloboto village on Saturday

A 34 year old man was arrested for possession of drugs estimated at a street value of R58 000 at Mokgoloboto village on Saturday.

This follows a clean-up operation by the Ritavi Crime prevention, Politsi K9 Unit and the Tzaneen Cluster Crime Intelligence focusing on the mushrooming of drugs.

During the arrest the following drugs were recovered, 19 grams of cat, 12 units of cocaine and 102 grams of tick.

Police investigations are still continuing.

Police spokesperson, Lieutenant Colonel Moatshe Ngoepe, said the clean-up operations are still continuing until all the hotspot areas throughout this province are demolished.

## Crime reports for the past week

Tzancen: Police in Tzaneen have arrested 23 suspects for various criminal activities over the past week.

According to Tzaneen police spokesperson, Captain Joseph Moseri, one suspect was arrested for theft, seven for shoplifting, one for failure to comply with maintenance order, five for possession of dagga, one for assault with intent to do grievous bodily harm, one for malicious damage to property, one for reckless and negligent driving, one for Crimen Injuria, one for carjacking,

one for escaping from lawful custody, two for possession of suspected stolen property, one for rape and one suspect was arrested for drunken driving.

Bolobedu: Police in Bolobedu have arrested 13 suspects for various criminal activities over the past week.

According to Bolobedu police spokesperson, Constable Millicent Mohale, one suspect was arrested for possession of suspected stolen motor vehicle, one for theft of motor vehicle, two for possession of dagga, one for sexual assault, one for resisting warrant of arrest, two for assault with intent to do grievous bodily harm, one for housebreaking and theft, one for stock theft and two suspects were arrested for illegal gambling.

Letsitele: Police in Letsitele have arrested 18 suspects for various criminal activities over the past week.

According to Letsitele police spokesperson, Warrant Officer Nkateko Nhlangwana, six suspects were arrested for public drinking, four for contravention of the Road Traffic Act, two for assault, for rape, one for robbery, one for attempted rape, one for possession of firearm and ammunition and one suspect was arrested for intimidation.
