ENVIRONMENTAL IMPACT ASSESSMENT (EIA) PROCESS: PROPOSED 400kV ELECTRICITY TRANSMISSION LINE BETWEEN ORANJEMOND AND JUNO SUBSTATIONS AND THE UPGRADING OF THESE SUBSTATIONS (KUDU INTEGRATION PROJECT)

As you may be aware, Eskom Transmission is proposing to construct a 400kV power line from Nampower's proposed Kudu gas-fired power station near Oranjemund in Namibia to the Juno substation near Vredendal in the Western Cape, in order to supply electricity to the Western Cape.

Eskom Transmission has appointed Strategic Environmental Focus (SEF) as independent environmental consultants to manage the environmental impact assessment (EIA) process to assess the environmental impacts of this proposed power line. SEF is responsible for compiling an Environmental Impact Report (EIR) that will be submitted to the Department of Environmental Affairs and Tourism for decision-making. The Western Cape's Department of Environmental Affairs and Development Planning and the Northern Cape Department of Tourism, Environment and Conservation will also provide an input to this decision.

SEF has completed the Scoping phase of the EIA process, and are now embarking on the EIA phase. The DEAT approved SEF's Scoping Report and provided approval of the Plan of Study for EIA, thus allowing SEF to proceed to the compilation of an EIR.

Since the completion of the Scoping report, a number of alternative alignments of the proposed power line have been suggested in order to mitigate the impacts thereof. This has resulted in additional potentially interested and affected parties being identified. Thus, SEF is informing you, as a directly affected / neighbouring landowner, of the EIA process and inviting you to participate in this process.

The draft EIR will be made available for public comment from 20 November 2006 to 22 January 2007. The report will be made available at the following venues in the affected area
