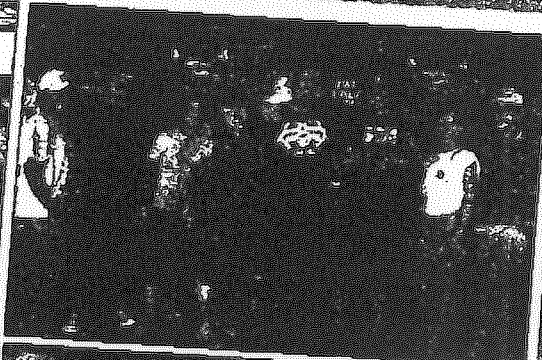


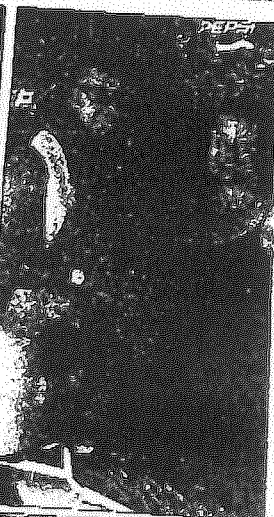

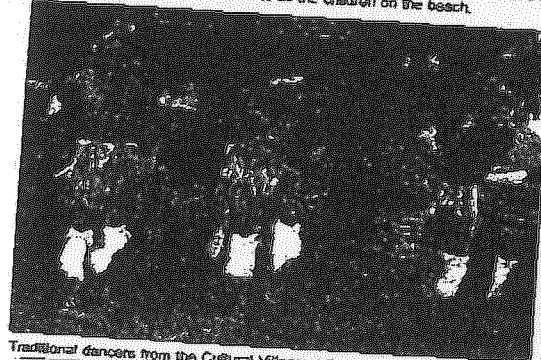

NOTICE OF ENVIRONMENTAL IMPACT ASSESSMENT PROCESS

Notice is hereby given in terms of Regulations 56 of the regulations published in Government Notice No. R. 385 in terms of the National Environmental Management Act, 1998 (Act No 107 of 1998), as amended, of intent to carry out the following activities:

- Construction of the Dwaalboom 132kV switching station, turn-in lines and associated secondary infrastructure. Reference number: 12/12/20/1188.
- An application for an Environmental Impact Assessment was made to the Department of Environmental Affairs and Tourism in order to obtain authorization for the above-mentioned project. The Scoping Report for this project was approved by DEAT and Nemat Consulting is currently in the Environmental Impact Assessment phase of the project.

Description and Extent - The proposed switching station is required to ensure that the Dwaalboom PPC plant receives a constant supply of electricity. The switching station will have a 100m x 300m footprint, which will contain the switching station itself as well as all secondary infrastructure. The switching station would contain a control room, a communications mast, six bay double bus-bar, a floodlight, an auxiliary 132/10kV 10MVA transformer and a 400L oil dam. The switching station will be fenced for security and safety reasons. Secondary infrastructure will be housed within the control room. Four terminal towers will be required to take the electricity in and out of the switching station.

Location - The three locality alternatives are all located on the farm De Paarl 246, within the Moes Kotane Local Municipality and the Bojanala Platinum District Municipality.
