#### 2. FORMAT OF THE MEETING

All protocols at the Mdletshe Traditional Council were observed. The meeting was opened with a prayer.

All information was presented in isiZulu and all proceedings were conducted in isiZulu.

#### 4. OBJECTIVES OF THE MEETINGS

The primary objectives of the meeting were as follows:

- Introduce the proposed Eskom Northern KZN Strengthening Project to the community and initiate discussions as part of the Environmental Impact Assessment (EIA) process.
- Outline the environmental authorisation process that will be followed in undertaking the EIA process.
- Provide an opportunity for stakeholders to provide input in the EIA process; and

 Advise on the ongoing public consultation process, identification of issues and next phases in the process.

#### 5. CONTENT OF THE PRESENTATION

The following information was presented at the meeting:

- Background and description of the project.
- The need and motivation of the project.
- The description of the EIA process.
- The description of the Public Participation Process.
- The study area and proposed alternative corridors and substation.
- The locality of the communities in relation to the proposed corridors.
- Submission of comments, project timeframes and future phases of the EIA.

#### 6. SUBMISSION OF COMMENTS

All comments raised and discussed were recorded at the meeting including responses provided. In instances where responses were not readily available, comments were noted for passing on to the relevant officials.

Due to the remoteness of most rural areas, an alternative method for submission of comments was provided to the community. Community members were advised to submit any additional comments to the Secretary of the Traditional Council, who will thereafter liaise with the Public Participation Office for collection.

#### 7. COMMENTS RAISED AND DISCUSSED

1	Inkosi Mdletshe	How will people who have been relocated be compensated?	The servitude negotiation process is a private matter between Eskom and the affected landowner. This process will only commence once Environmental Authorisation has been issued. Eskom will compensate for any loss resulting from these restrictions.
			Once the route is confirmed (i.e. options are signed with the landowners), the servitude agreement will be finalised with the individual landowners. Different

			landowners may have different requirements. Compensation payments are made when the servitude is registered at the Deeds office.
			In instances of relocation of houses, Eskom appoints a contractor to build houses for the affected families.
2	A Stakeholder Mdletshe TC	The community believes that illegal connections are a burden to those households who pay for electricity as they end up paying more.	The issue of illegal electricity connections within households has been noted and will be passed on to Eskom Distribution for a response.
3	A Stakeholder Mdletshe TC	Electricity supply in the area is very weak. How does the community get information on load shedding times and duration thereof?	Eskom Distribution usually communicates and/or issue notices to the areas which will be affected or experience power supply interruptions. The Eskom Customer service centre can also be contacted to get more information on load shedding.
4	A Stakeholder Mdletshe TC	Before the Local Government elections, August 2016, people were requested to register for electrical installations in their houses but nothing has materialised.	The proposed Eskom Northern KZN Strengthening project deals with bulk electricity transmission. Issues relating to the electrification programme should be followed up with the local supplier and/or municipality.
5	A Stakeholder Mdletshe TC	Will the new substation and new power lines have an effect on the price of electricity in the area?	Electricity tariffs are regulated by the National Energy Regulator of South Africa (NERSA). They regulate the price increases for customers supplied directly by Eskom and those supplied by municipalities.
			Upgrading the infrastructure in the northern KZN does not necessarily mean that consumers in northern KZN will be paying more. NERSA regulates all tariff increases in line with their mandate as a regulatory body.

# 8. NEXT STEPS IN THE EIA PROCESS

The following information was outlined as part of the way forward:

- All members of the public will be advised of the availability of the Draft Scoping Report (DSR) and Draft Environmental Impact Report (EIR) for public review.
- Communication with Mdletshe Traditional Council will continue for the duration of the EIA.
- All traditional councils will be informed whether they are or not affected by the preferred corridor when environmental authorisation has been issued by the Department of Environmental Affairs.
