The existing 132kV Powerline running from the existing Dysselsdorp Substation to the existing Oudtshoorn Substation requires refurbishment. Unfortunately, it is not possible to rebuild the Dysselsdorp - Oudtshoorn 132kV Powerline as it runs partly through built-up environment. As part of an overall network solution and for practical reasons, Eskom is proposing a new 132kV corridor between the existing Outeniqua and Outdsthoorn Substations. The existing Dysselsdorp-Oudtshoorn Powerline can then be refurbished but the Outenqua to Dysselsdorp 132kV line refurbishment can be further delayed.
