

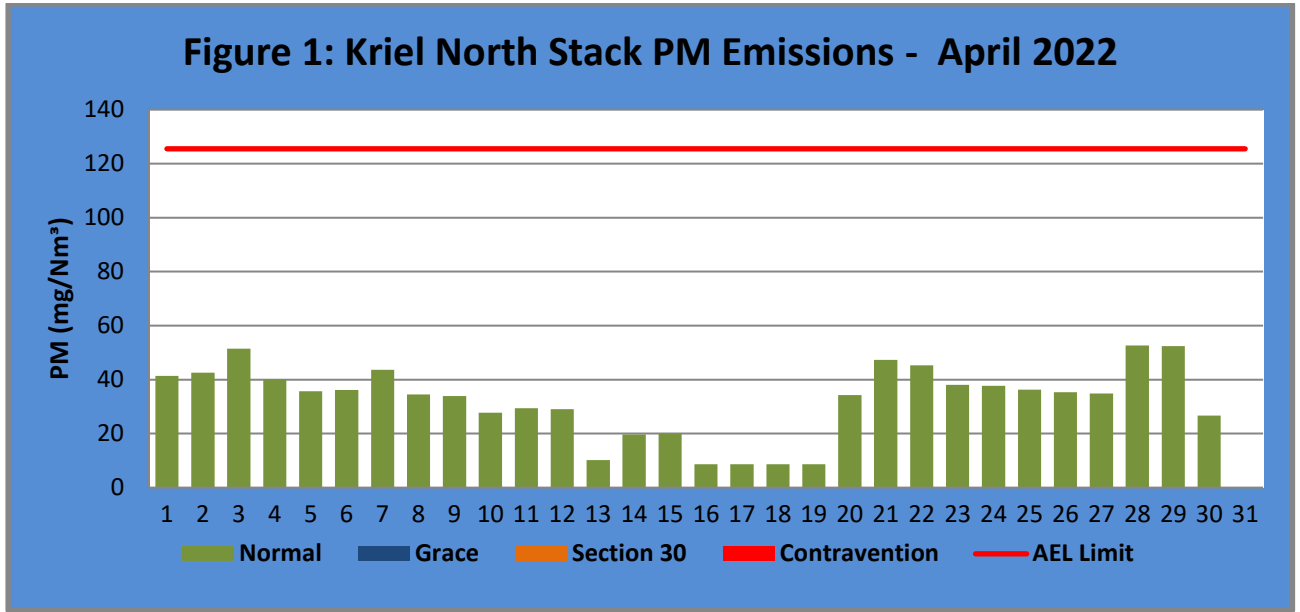


Figure 1: PM emissions for the month of April 2022 against emission limit for the North Stack. Monthly average was 32.4 mg/Nm<sup>3</sup>

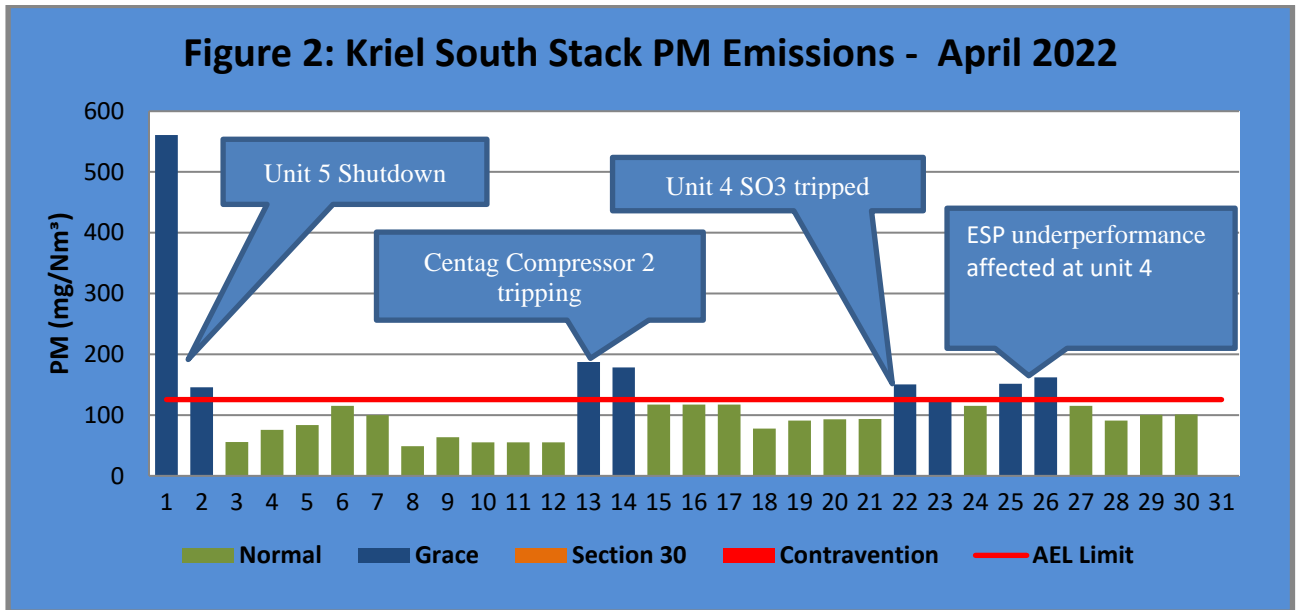


Figure 2: PM emissions for the month of April 2022 against emission limit for the South Stack. Monthly average was 120.1 mg/Nm<sup>3</sup>

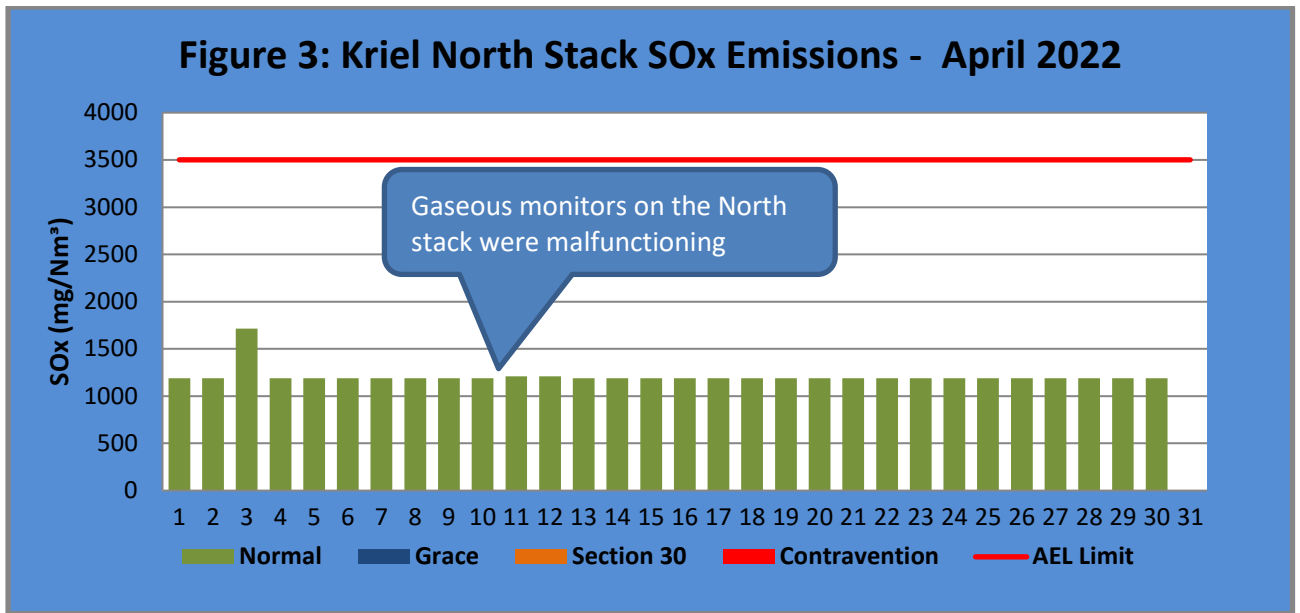


Figure 3. SO<sub>2</sub> emissions for the month of April 2022 against emission limit for the North Stack. The SO<sub>x</sub> Limit is 3500mg/Nm<sup>3</sup>.

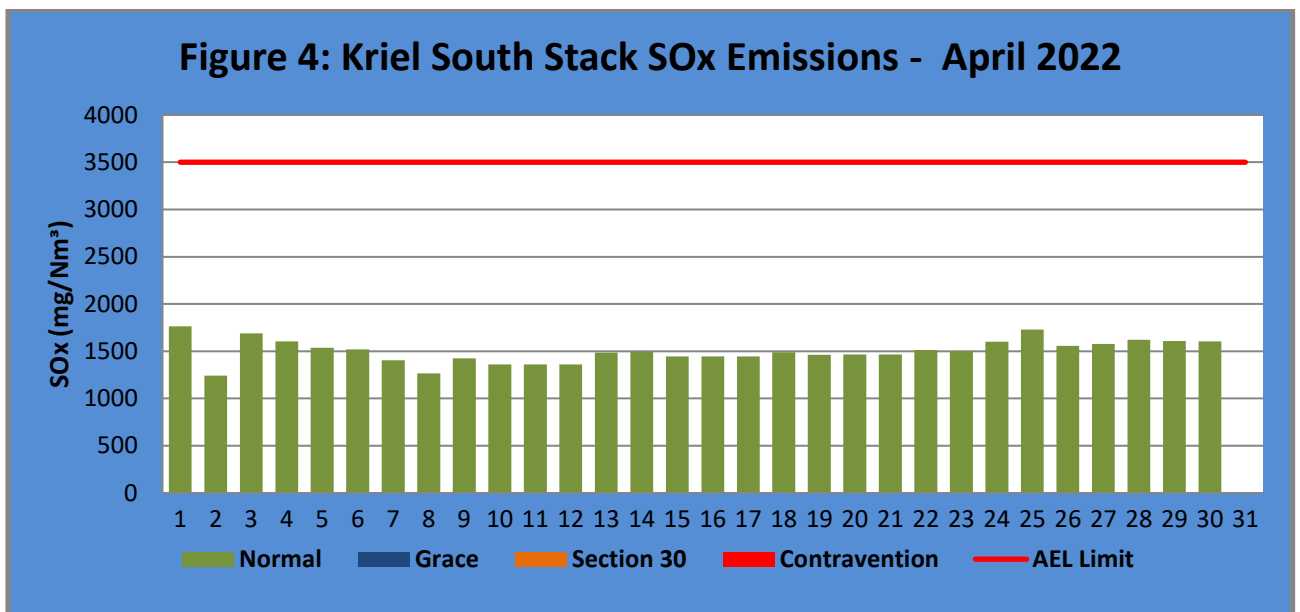


Figure 4. SO<sub>2</sub> emissions for the month of April 2022 against emission limit for the South Stack. The SO<sub>x</sub> Limit is 3500mg/Nm<sup>3</sup>.

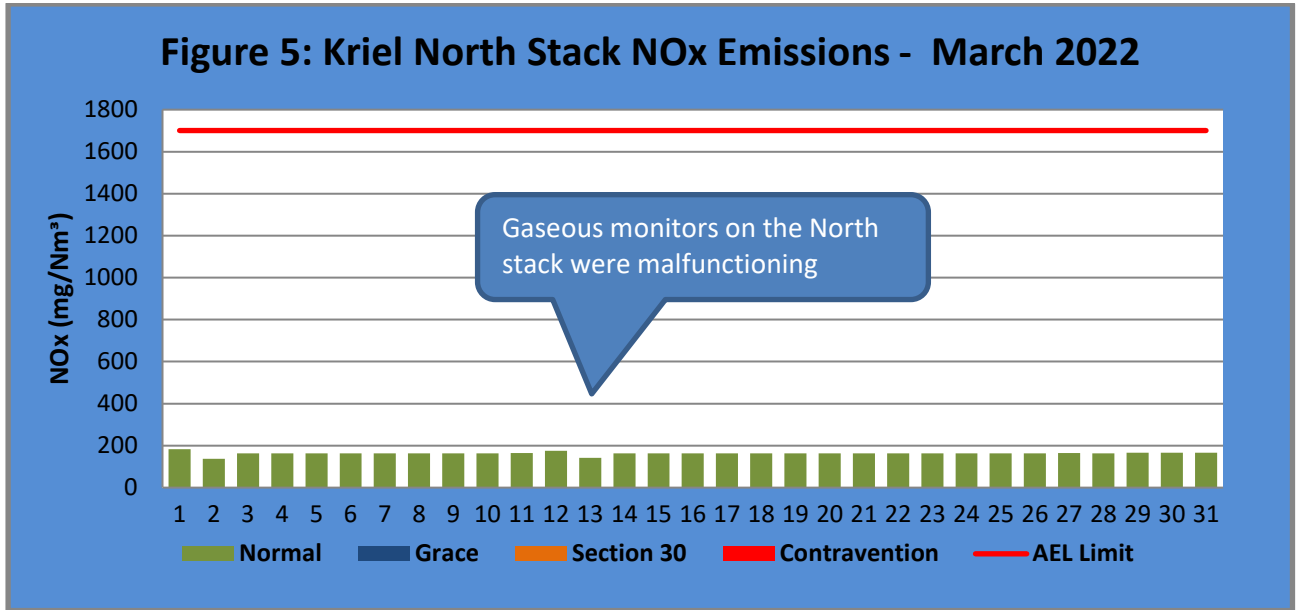


Figure 5. NO<sub>2</sub> emissions for the month of April 2022 against emission limit for the North Stack. The NO<sub>x</sub> Limit is 1600mg/Nm<sup>3</sup>.

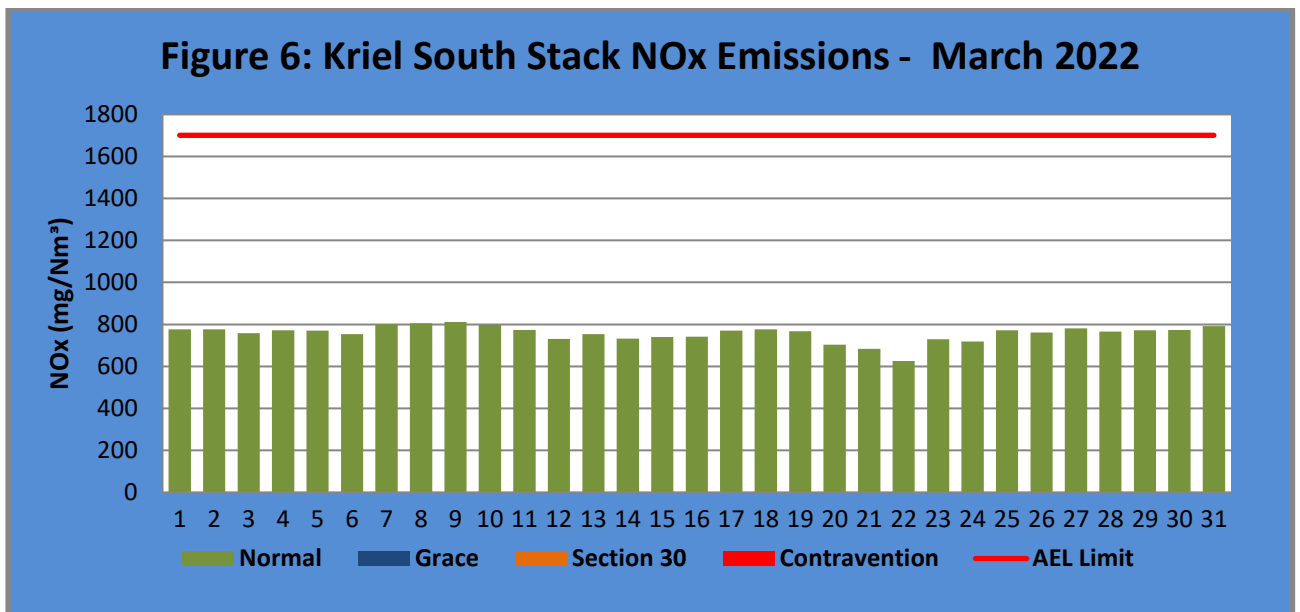


Figure 6. NO<sub>2</sub> emissions for the month of April 2022 against emission limit for the South Stack. The NO<sub>x</sub> Limit is 1600mg/Nm<sup>3</sup>.

### General

The particulate matter (PM10) emissions on the North and South Common Stacks were within the **monthly limit**; North stack recorded the monthly PM10 average emissions figure of **32.4 mg/Nm<sup>3</sup>** and the South Stack recorded PM10 monthly average figure of **120.1 mg/Nm<sup>3</sup>**. The gaseous (NOx & SOx) emissions on the north and south common stacks were also within the **daily limit** during the month of April 2022; refer to graphs above. However The North Common Stack gasous monitors are defected.

NB: The rest of the information demonstrating compliance with the emissions license conditions is supplied in the annual emission reports sent to your office.
