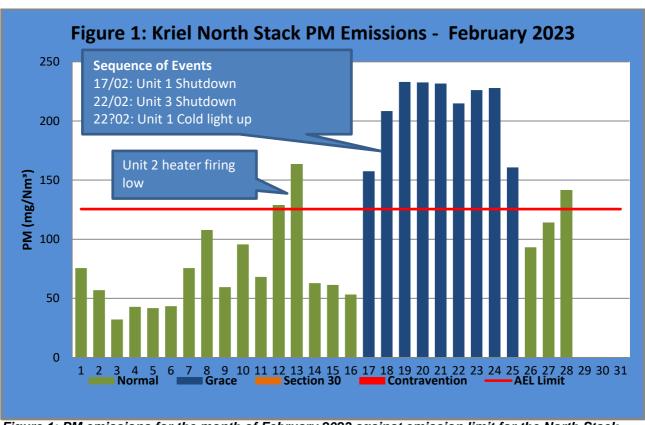


Figure 1: PM emissions for the month of February 2023 against emission limit for the North Stack. Monthly average was 121.8 mg/Nm3

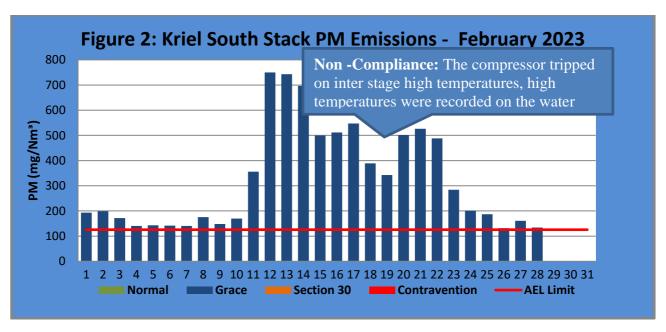


Figure 2: PM emissions for the month of February 2023 against emission limit for the South Stack. Monthly average was 324.1 mg/Nm3

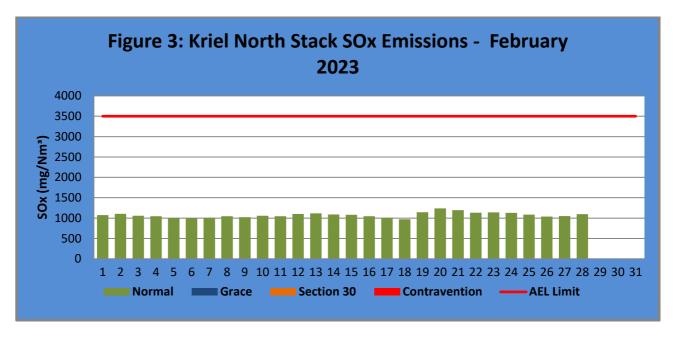


Figure 3. SO<sub>2</sub> emissions for the month of February 2023 against emission limit for the North Stack. The SOx Limit is 3500 mg/Nm3.

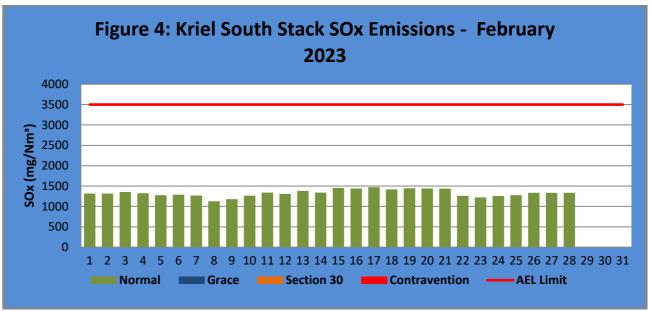


Figure 4. SO<sub>2</sub> emissions for the month of February 2023 against emission limit for the South Stack. The SOx Limit is 3500 mg/Nm3.

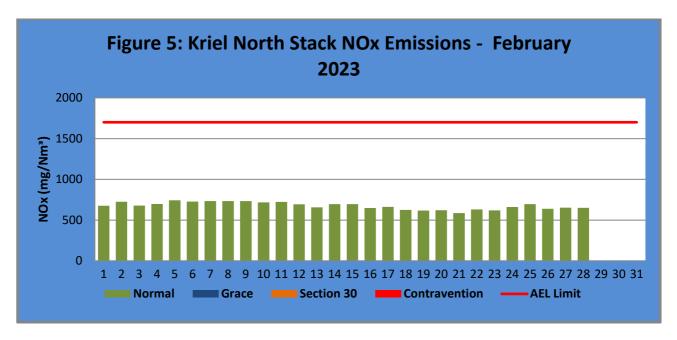


Figure 5.  $NO_2$  emissions for the month of February 2023 against emission limit for the North Stack. The NOx Limit is 1600 mg/Nm3.

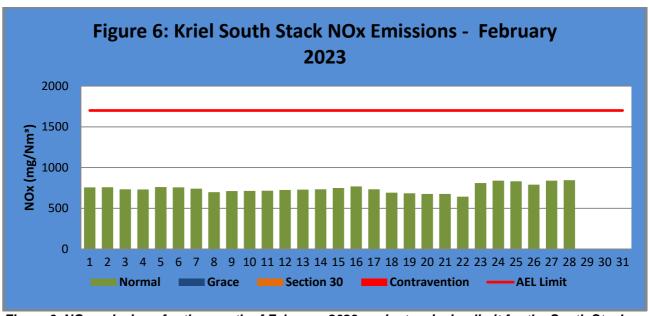


Figure 6. NO<sub>2</sub> emissions for the month of February 2023 against emission limit for the South Stack. The NOx Limit is 1600 mg/Nm3.

### General

The particulate matter (PM10) emissions on the North Common Stack were within the **monthly limit**; North stack recorded the monthly PM10 average emissions figure of **121.8 mg/Nm3** while South Common Stack exceeded the **monthly limit** and recorded PM10 monthly average figure of **342.1 mg/Nm3**. The gaseous (NOx & SOx) emissions on the north and south common stack were also within the **daily limit** during the month of February 2023; refer to graphs above.
