


Figure 1: PM emissions (daily averages) for the month of September 2022 against the emission limit for the North Stack




Figure 2: PM emissions (daily averages) for the month of September 2022 against emission limit for the South Stack




Figure 3: SO<sub>2</sub> emissions (daily averages) for the month of September 2022 against emission limit for the North Stack




Figure 4: SO<sub>2</sub> emissions (daily averages) for the month of September 2022 against emission limit for the South Stack




Figure 5: NO<sub>2</sub> emissions (daily averages) for the month of September 2022 against emission limit for the North Stack




Figure 6: NO<sub>2</sub> emissions (daily averages) for the month of September 2022 against emission limit for the South Stack
