Approval of Eskom Retail Tariff and Structural Adjustment Application (ERTSA) and the Schedule of Tariffs for the period 01 April 2023 to 31 March 2024

On 10 March 2023, the National Energy Regulator of South Africa (NERSA), considered your application for the Eskom Retail Tariffs and Structural Adjustment (ERTSA) and the Schedule of Approved Tariffs and decided as follows:

- The introduction of the Homeflex Tariff for residential customers as outlined in the Eskom Retail
  Tariff Plan (RTP) submitted by Eskom on 5 August 2022 and the revised version of the tariff
  submitted on 28 February 2023.
- 2. The Schedule of Retail Tariffs for the various tariff categories be increased as follows:
