Approval of Eskom Retail Tariff and Structural Adjustment Application (ERTSA) and the Schedule of Tariffs for the period 01 April 2024 to 31 March 2025

On 14 December 2023, the National Energy Regulator of South Africa (NERSA), considered your application for the Eskom Retail Tariffs and Structural Adjustment (ERTSA) and the Schedule of Approved Tariffs and decided as follows:

 Approve that the average tariff increases for the respective customer categories and affordability subsidy that must be recovered from industrial and urban customers, as outlined in Table 1 below The Schedule of Retail Tariffs for the various tariff categories be increased as follows:

The Minister of Finance last proclaimed a VAT increase in 2018, from 14% to 15%.
