BERG-OLIFANTS WATER MANAGEMENT AREA: WATER USE AUTHORISATION IN TERMS OF THE NATIONAL WATER ACT, 1998 (ACT 36 OF 1998): SECTION 21 (C) IMPEDING OR DIVERTING THE FLOW OF WATER IN A WATERCOURSE AND SECTION 21 (I) ALTERING THE BED, BANKS, COURSE OR CHARACTERISTICS OF A WATERCOURSE FOR ESKOM HOLDINGS, CAPE TOWN

Your application for a water use authorisation and registration dated 15 June 2017 bears reference.

The impeding or diverting the flow of water in a watercourse and altering the bed, banks, course or changing the characteristics of a watercourse are two separate water uses which require authorisation from the Department of Water and Sanitation prior to commencement. The Department has evaluated the submitted documents and hereby confirms that the proposed water uses fall within the ambit of the General Authorisation, Government Gazette No. 40229, Notice No. 105, dated 26 August 2016. Therefore, you may continue with the water uses as permissible in terms of Section 22 (1) (a) (iii) of the National Water Act, 1998 (Act 36 of 1998). Details of the water uses which will be registered appear in Table 1.

- b) The period is extended by a notice in a Gazette;
- c) It is replaced by a general authorization in relation to a specific water resource or within a specific area; or
- d) The water user is instructed in writing by the responsible authority to apply for a licence.

Your water use (s) will be registered for the basis of the Department's records and/ or billing. Once your water use (s) has been registered you need to review the certificate, that you will receive within the ensuing weeks, and inform the Department within one calendar month (from the date of the certificate) should there be any errors which may have occurred. The responsibility for complying with all the provisions of the General Authorisation is vested in the water user and not any other person or body. Non-compliance constitute an offence, and it will be dealt with in terms of Section 53, 54 and 151 (2) of the National Water Act, 1998. (Act 36 of 1998).
