The matter above has reference.

Heritage Western Cape is in receipt of your correspondence on the above matter, dated 5 November 2012 and the following discussed:

- 1. The site is located from Oudtshoorn south to the Outeniqua substation.
- 2. The proposal is to construct a 27km (Alternative A) or 25km (Alternative B) 132kV power line linking two substations.
- 3. Alternative A follows the route of existing power lines.
- 4. Alternative B will be new running roughly parallel to the N12 but joining Alternative A 7.8km south of Outdshoorn Substation.
- 5. Two historical sites were found a small ruin near the LSA site and a rectangular cobbled structure.
- 6. A two scatters of ESA/MSA material were found. The scatters included a bifacial artefact as well as numerous other tools.
- 7. One Later Stone Age site was found on a river bank.
- 8. Some graveyards are located around the Oudtshoorn Substation. Though the graves were exhumed there is the possibility for isolated grave to occur in the vicinity.

Decision:

- Heritage Western Cape agreed that alternative A is supported. Should alternate B be selected by the decision maker, HWC requires that a visual Impact be submitted to HWC in order to mitigate impacts.
- 2. If any burials are found which have not been exhumed, they should be exhumed (similarly to those already found).
