APPROVAL OF THE FINAL ENVIRONMENTAL MANAGEMENT PLAN FOR THE DECOMMISSIONING AND RELOCATION OF THE THREE GAS TURBINE UNITS AT ACACIA POWER STATION (NEAR GOODWOOD, WESTERN CAPE) AND ONE GAS TURBINE UNIT AT PORT REX POWER STATION (NEAR EAST LONDON, EASTERN CAPE) TO THE EXISTING ANKERLIG POWER STATION SITE, IN ATLANTIS INDUSTRIA, WESTERN CAPE PROVINCE

The Environmental Management Plan (EMP) dated July 2009 regarding the above-mentioned project received by this Department on 31 July 2009 refers. You have submitted this document in order to comply with the requirements of the conditions of the Environmental Authorisation granted on 20 February 2009.

This Department has accepted, evaluated and hereby approves the EMP for the above-mentioned project. The EMP adequately addresses possible impacts associated with the construction and operational phases of the project. This EMP addendum for the proposed decommissioning and relocation of the Acacia and Port Rex Power Station gas turbines to the Ankerlig Power State site must be read in conjunction with the relevant sections and appendices of the Ankerlig OCGT Power Station EMP (Revision 1 dated September 2007).

This EMP should be regarded as a 'living document', which may be amended from time to time as and when the need arises. Amendments to the EMP must be approved by this Department.
