

Bail for murder accused

The woman charged with the murder of her husband, Tizziano Ciciliato, was released on bail on Monday.

Ronell Botma together with sisters Anna and Buhle Dina Mokwana appeared in court on Monday for judgement on their bail hearing.

The other accused in the matter Doctor Jacob Tlou, Tsietsi Letsebe, Hendrik Chego and Mbuzo Khoza abandoned their bail application.

Magistrate Hans Combrinck said that the large amount of documents before court forced him to adjourn on Friday. He said however that the matter was not complicated.

The women are accused of a schedule six offence wherein they should only be released on bail if exceptional circumstances exist.

Magistrate Combrinck said that there was no evidence before the court that the women posed any threat to society. He said that if they ever were a threat to someone it was to Mr Ciciliato and him alone.

Mrs Botma's daughter Vicky, who currently resides in Korea, was laid before court by the state to imply that she might be a flight risk.

This was rejected by magistrate Combrinck who said documentation that proved that Vicky had to return to South Africa in a couple of months was handed in.

Mrs Botma plans to enter a defence of abused spousal syndrome. Magistrate Combrinck said that if this can be proven it will drastically affect the outcome of sentencing.

Mrs Botma was released on R10 000 bail, Anna Mokwana on R5 000 and Buhle Mokwana on R1 000.

They, together with their four co-accused, will appear in court again in March to face charges of murder, conspiracy to murder, robbery with aggravating circumstances and defeating the ends of justice.

Karwag voor vir moord

Perrow se erg ontbinde lyk is in die spruit in Mineralia ontdek deur twee mense wat met hul honde gaan stap het.

Haar lyk is uitgeken aan 'n tatoeërmerk op haar skouer. Appelgryn is kort daarna gearresteer.

Hy het aanvanklik 'n bekentenis afgelê maar dit later teruggetrek en beweer dat hy dit afgelê het

nadat hy deur die polisie aangerand is.

Dit het aan die lig gekom dat Perrow se skedel vermoedelik vergruis is en sy toe aan die brand gesteek is.

Appelgryn se saak is uitgestel tot April vir verdere verhoor.

Hy is tans uit op borg en bly by familie in eMahlaleni.
