Notice is hereby given that the Draft Environmental Impact Assessment Report (DEIR) and the draft specialist reports for the integrated Environmental Authorisation and Waste Management Licence Application (IWMLA) for the co-disposal of ash and gypsum at the Kusile Power Station are now available for comment. The IWMLA was submitted to the Department of Environmental Affairs (DEA) on 17 August 2012 (DEA Ref: 14/12/16/3/3/3/51 and NEAS Ref: DEA/EIA/0001413/2012). In response to this application, the DEA requested that an EIA be conducted, taking into account all the applicable Departmental Guidelines throughout the application process. The Scoping Phase of the application was conducted, including the public participation process. The DEA formally accepted the Final Scoping Report on 14 November 2013, allowing the process to continue into the Impact Assessment Phase. This phase entailed conducting specialist studies and drafting an EIR.
