PROGRESS FEEDBACK AND NEXT STEP OF THE EIA

This letter serves to provide you with feedback on the current status of the EIA process and the next steps in this process.

1 REVISED DRAFT ENVIRONMENTAL IMPACT REPORT DATED 26 APRIL 2011

A Revised Draft Environmental Impact Report (EIR) dated 26 April 2011 was provided to the public and the Department of Environmental Affairs (DEA) for comment. All registered I&APs were notified via letters of the Revised Draft EIR's availability at twenty four (24) public venues during the comment period (09 May to 7 August 2011). Public meetings were held from 23 May to 02 June 2011. Feedback was received on the Revised Draft EIR from the DEA in January 2013.

2 DRAFT EIR VERSION 2 AND SPECIALIST STUDIES

Substantive changes are being made to the Draft EIR and some specialist studies in response to the DEA and public comments. It is anticipated that the Draft EIR Version 2 will be provided for public comment towards the end of the last quarter of 2013. All registered I&AP's will be advised in good time of the availability of the Draft EIR Version 2 and the venues where they will be placed. The dates of public meetings, the venues for these meetings and the venues where the EIR will be provided will also be communicated in due course. The availability of the EIR and the public meetings will be extensively advertised in the press.
