Notice is hereby given in terms of the Environmental Impact Assessment Regulations, 2006, published in Government Notices No. R386, R387 of 21 April 2006 under the National Environmental Management Act, 1998 (Act No. 107 of 1998) of Eskom's intent to carry out the following activity that requires environmental authorisation:

The potential construction of a Nuclear Power Station and associated infrastructure in either the Eastern, Northern or Western Cape provinces. An application for the proposed activity has been submitted to the National Department of Environmental Affairs and Tourism.

A number of potential sites have been identified as part of initial investigations.

- Bantamsklip (Western Cape – 10 km south-east of Pearly Beach)
- Brazil (Northern Cape – Kleinsee/Port Nolloth area)
- Duynefontein (Western Cape – Adjacent to the existing Koeberg Power Station, Cape Town)
- Schulpfontein (Northern Cape – Hondeklipbaai/Kleinsee area)
- Thyspunt (Eastern Cape – West of Port Elizabeth near Cape St Francis)
