APPLICATION FOR ENVIRONMENTAL AUTHORISATION R.385 &, R.386, R. 387: PROPOSED EXTENSION / UPGRADE OF THE VERWOERDBURG 400/132 kV SUBSTATION AND CONSTRUCTION OF A 2 X 400 kV NEW LOOP IN LINES FROM THE APOLLO-PLUTO TRANSMISSION LINES TO FEED INTO THE VERWOERDBURG SUBSTATION, GAUTENG PROVINCE



> R. 387 1(I): The construction of facilities or infrastructure, including associated structures or infrastructure, for -

as described in the Final Environmental Impact Assessment Report (EIR) dated April 2010, page 1, as follows:

The proposed activity and associated infrastructure involves the extension of the Verwoerdburg (Rietvlei) substation and construction of 2 x 400 kV loop in and out transmission power line between Apollo-Pluto from Verwoerdburg substation.

The granting of this Environmental Authorisation is subject to the conditions set out below.

Conditions

Scope of authorisation

1. Authorisation of the activity is subject to the conditions contained in this Authorisation, which conditions form part of the Environmental Authorisation and are binding on the holder of the authorisation.

- The holder of the authorisation shall be responsible for ensuring compliance with the conditions contained in this Environmental Authorisation. This includes any person acting on the Applicant's behalf, including but not limited to, an agent, servant, contractor, sub-contractor, employee, consultant or person rendering a service to the holder of the authorisation.
- The activity authorised may only be carried out at the property indicated above. 3.
- Any changes to, or deviations from, the project description set out in this Authorisation must be approved, in writing, by the Department before such changes or deviations may be effected. In assessing whether to grant such approval or not, the Department may request such information as it deems necessary to evaluate the significance and impacts of such changes or deviations and it may be necessary for the holder of the Authorisation to apply for further Authorisation in terms of the Regulations.
- This activity must commence within a period of three (3) years from the date of issue. If 5. commencement of the activity does not occur within that period, the authorisation lapses and a new application for Environmental Authorisation must be made in order for the activity to be undertaken.
- This Authorisation does not negate the holder of the Authorisation's responsibility to comply with any other statutory requirements that may be applicable to the undertaking of the activity.
 - 6.1. Relevant legislation that must be complied with by the holder of this authorisation includes:
 - Archaeological remains, artificial features and structures older than 60 years are protected by National Heritage Resources Act, 1999 (Act No. 25 of 1999). Should any archaeological artefacts be exposed during excavation for the purpose of construction, construction in the vicinity of the finding must be stopped. A registered heritage specialist must be called to the site for inspection. Under no circumstances shall any heritage material be destroyed or removed from the site. The relevant heritage resource agency must be informed about the finding. Heritage remains uncovered or disturbed during earthworks must not be disturbed further until the necessary approval has been obtained from the South African Heritage Resources Agency and/or any of their delegated provincial agencies.
 - All provisions of the Occupational Health and Safety Act, 1993 (Act 85 of 1993).
 - All provisions of the National Water Act, 1998 (Act 36 of 1998).
 - All provisions of the National Forests Act, 1984 (Act No. 122 of 1984).
 - All provisions of the National Environmental Management: Biodiversity Act, 2004 (Act 10 J24/6/2010 of 2004).

- All provisions of the National Environmental Management: Protected Areas Act, 2003 (Act 57 of 2003) and its Regulations.
- All outdoor advertising i.e. signage boards associated with this proposed activity must be below the thresholds stipulated in the EIA Regulations as it was not applied for as an activity for authorisation during the Environmental Authorisation process. Should the holder of the Environmental Authorisation wish to exceed these thresholds he/she must submit an application for authorisation to this Department. Further, all outdoor advertising associated with this proposed activity, whether on or off the property concerned, must comply with the applicable Local Authority By-Law for the control of Outdoor Advertising or in the absence of local legislative controls, must comply with the South African Manual for Outdoor Advertising Control (SAMOAC).
- 8. Should fill material be required for any purpose, the use of borrow pits must comply with the provisions of the Minerals and Petroleum Resources Development Act, 2002 (Act 28 of 2002) administered by the Department of Minerals and Energy.
- A permit must be obtained from the relevant nature conservation agency for the removal or destruction of indigenous protected and endangered plant and animal species. At all times the principles of search and rescue of species must be explored prior to destruction.
- 10. Alternative Route 3a as shown in Figure 6.2 and 6.3 of the Final EIR Report is approved for the proposed 2 x 400kV transmission new loop in power lines from the Apollo-Pluto transmission lines to feed into the Verwoerdburg Substation.
- 11. A total area of 300m² is approved for the extension of the substation as shown on Figure 2.2 of the EIR dated April 2010. The maximum height of the substation development must be 25m.
- 12. Extension of the existing fences will be installed to secure the substation and the substation site.

 These fences include a 2.4m high security fence to enclose all assets, a 1.8m high fence around the yards, and a 1.2m high boundary fence on the property-line.
- 13. All construction activities and/or earthworks must be carried out within the limits of the authorised site.
- 14. All mitigation measures as detailed within the Draft EMP must be implemented, monitored and audited.
- The Draft EMP should form part of the contract with the Contractors appointed to construct and maintain the proposed Tshwane Strengthening Project.
- 16. The EMP must be implemented throughout the life cycle of the proposed project.
- 17. An omithologist must identify the exact power line spans requiring marking in order to minimise the risk of collision of birds with the earth wire.

- 18. It is recommended that bird guards be installed on all self-supporting towers according to the existing Eskom guidelines.
- 19. An ecologist must be appointed to do a final walk through before construction in order to identify and relocate any possible plant species or conservation importance.
- 20. During construction, unnecessary disturbance to habitats should be strictly controlled and the footprint of the impact should be kept to a minimum.
- 21. The EMP for construction must be updated to include site-specific information and specifications resulting from the final walk-through surveys and recommendations made by Specialist Reports. Currently, the EMP veers towards generic construction mitigation measures. This updated EMP must be submitted to DEA for approval prior to the commencement of construction on site.
- 22. It is recommended that monopole structures are utilised in densely populated areas.
- 23. It is recommended that the following be implemented or monitored by the social engagement officer or the ECO: An Influx Management Plan; A Social Management Plan during construction and operation; A Decommissioning and Closure Plan; A Local Labour and Workforce Plan, A Stakeholder Engagement Plan; A grievance mechanism for the construction and operation phases; and Social Impact Assessment during construction and implementation.
- 24. All areas disturbed during the Construction Phase must be rehabilitated at the end of the construction phase.
- 25. Generation of dust must be minimised and dust control measures must be implemented.
- 26. Exposed soil and material stockpiles must be protected against the wind.
- 27. Covered dust bins must be provided on site in order to handle all waste generated during construction. When the dust bins are full, all waste must be removed from the site and be disposed of at a licensed disposal site.

Appeal of Authorisation

- 28. The holder of the authorisation must notify every registered Interested and Affected Party (I&AP), in writing and within seven (7) calendar days, of receiving notice of the Department's decision to authorise the activity.
- 29. The notification referred to in 28 must -
 - 29.1. specify the date on which the authorisation was issued;
 - 29.2. inform the interested and affected party of the appeal procedure provided for in Chapter 7 of the regulations;

- 29.3. advise the interested and affected party that a copy of the authorisation will be furnished on request; and
- 29.4. give the reasons for the decision.

Management of the activity

- 30. The Environmental Management Plan submitted as part of the EIR dated April 2010 (EMP) must be implemented and strictly enforced during all construction activities. The EMP will be seen as a dynamic document. The EMP must be included in all contract documentation for the construction phase of the development.
- 31. The recommendations and mitigation measures recorded in the Final EIR submitted on April 2010 must be adhered to and incorporated as part of the EMP where applicable.
- 32. Measures for the management of heritage resources if such are exposed during construction must be implemented. Should any heritage resources be exposed during excavation for the purpose of construction, construction in the vicinity of the finding must be stopped immediately. A registered heritage specialist must be called to the site for inspection. Under no circumstances shall any heritage material be destroyed or removed from the site. The relevant heritage resource agency must be informed about the finding.
- 33. All correspondence with regard to this application must be forwarded for attention to The Director: Environmental Impact Evaluation within the department.

Monitoring

- 34. The Applicant must appoint an Environmental Control Officer (ECO) for the duration of the construction and rehabilitation phases of the development that will have the responsibility to ensure that the mitigation/rehabilitation measures recommendations referred to in this authorisation are implemented and to ensure compliance with the provisions of the EMP.
- 35. The ECO must be appointed before commencement of any land clearing or construction activities.
- 36. The ECO must, in addition to the requirements of the EMP, monitor project compliance with conditions of this environmental authorisation, environmental legislation and the recommendations for mitigation contained in the EIR.
 - 36.1. The ECO must keep record of all activities on site, problems identified, transgressions noted and a task schedule of tasks undertaken by the ECO and compliance monitoring.

- 36.2. Records relating to monitoring must be kept on site and made available for inspection to any relevant and competent authority in respect of this development within five (5) days upon request.
- 36.3. The ECO must remain employed until all rehabilitation measures, as required by the EMP are completed and the site is ready for operation.
- 36.4. The cost of the ECO shall be borne by the applicant.
- 36.5. The ECO must in addition to the requirements contained in the EMP also maintain the following on site:
 - A non-conformance register; and
 - A public complaints register.

Recording and reporting to the Department

- 37. The ECO must submit an environmental audit report to the Department upon completion of the construction and rehabilitation activities. This audit must:
 - 37.1. Indicate the date of the audit, the name of the auditor and the outcome of the audit in terms of compliance with the environmental authorisation conditions as well as the requirements of the EMP.
 - 37.2 Records relating to monitoring and auditing must be kept on site and made available for inspection to any relevant and competent authority in respect of this development.
- 38. The results of these audits must be submitted in writing to the Department within 10 (ten) days after completion of the audits. Should the reports indicate that there are significant detrimental impacts; the Department reserve the right to review its decision as indicated in the letter of authorisation.

Commencement of the activity

- 39. The construction of the authorised activity may not commence within thirty (30) days of date of signature of this authorisation.
- 40. Should you be notified by the Minister of a suspension of the authorisation pending any appeals decision on the authorised activities, you may not commence with the activities unless authorised by the Minister in writing.

Notification to authorities

41. Fourteen (14) days written notice must be given to the Department that the activity will commence. Commencement for the purposes of this condition includes site preparation. The notice must include a date on which it is anticipated that the activity will commence. This notification period may coincide with the period contemplated in 39 above.

Operation of the activity

42. Fourteen (14) days written notice must be given to the Department that the activity's operational phase will commence.

Site closure and decommissioning

43. Should the activity ever cease or become redundant, the applicant shall undertake the required actions as prescribed by legislation at the time and comply with all relevant legal requirements administered by any relevant and competent authority at that time.

General

- 44. A copy of this authorisation, the Final EIR dated April 2010 and the EMP dated April 2010 must be kept at the property where the activity will be undertaken. The authorisation must be produced to any authorised official of the Department who requests to see it and must be made available for inspection by any employee or agent of the holder of the authorisation who works or undertakes work at the property.
- 45. Where any of the applicant's contact details change, including the name of the responsible person, the physical or postal address and/or telephonic details, the applicant must notify the Department as soon as the new details become known to the applicant.
- 46. The holder of the authorisation must notify the Department, in writing and within 48 (forty eight) hours, if any condition of this authorisation cannot be or is not adhered to. Any notification in terms of this condition must be accompanied by reasons for the non-compliance. Non-compliance with a condition of this authorisation may result in criminal prosecution or other actions provided for in the National Environmental Management Act, 1998 and the regulations.

Annexure 1: Reasons for Decision

1. Background

The applicant, Eskom Holdings Limited applied for authorisation to carry out the following activities:

- > R. 387 1(I): The construction of facilities or infrastructure, including associated structures or infrastructure, for
 - I) The transmission and distribution of electricity above ground with a capacity of 120 kilovolts or more;
- > R. 386 1 (c): The above ground storage of a dangerous good, including petrol, diesel, liquid petroleum gas or paraffin, in containers with a combined capacity of 1000 cubic meters or more at any one location or site including the storage of one or more dangerous good, in a tank farm.
- > R. 386 14: The construction of masts of any material or type and of any height, including those used for telecommunications broadcasting and radio transmission, but excluding:
 - a) masts of 15 m and lower exclusively used by
 - i) radio amateurs; or
 - ii) for lightening purposes
 - b) flagpoles; and
 - c) lightening conductor poles.
- R 386 15: The construction of a road that is wider than 4 m or that has a reserve wider than 6 m, excluding roads that fall within the ambit of another listed activity or which are access roads of less than 30 m long.

The applicant appointed "Savannah Environmental (Pty) Ltd to compile an Environmental Impact Assessment Report (EIR) as required by Regulation 22 of the EIA Regulations, 2006.

2. Information considered in making the decision

In reaching its decision, the Department took, inter alia, the following into consideration -

- a) The objectives and requirements of relevant legislation, policies and guidelines, including section 2 of the National Environmental Management Act, 1998, (Act No. 107 of 1998), as amended.
- b) All issues raised by the Interested and Affected Parties.
- c) The findings of the Specialist Studies as included as Appendices I N of the Final EIR Report of April 2010.

3. Key factors considered in making the decision

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues, which, in the Department's view, were of the most significance, is set out below.

- a) The proposed activity and associated infrastructure involves the extension and upgrade of the existing Verwoerdburg Substation, construction of 2 x 400 kV loop-in and loop-out power lines from the existing Apollo-Pluto transmission line which will feed into the Verwoerdburg Substation.
- b) The current transmission power lines and substation infrastructure cannot supply the increased demand in the Gauteng North area. Studies undertaken show a steady average load growth in the area due to light industrialisation, commercialisation, urban growth and electrification within the area. Forecasts indicate continued growth resulting in additional power needs by 2013.
- c) Options to optimise existing transmission systems within the Tshwane Region has been assessed and it has been determined that new transmission power lines will be required in order to meet the predicted load requirements. The new lines will need to be brought into operation to coincide with the point when load growth and demand exceeds the supply (2012).
- d) The extension of Verwoerdburg Substation will largely take place within the existing substation site footprint that is already transformed and thus reducing the likely impacts.
- e) Three route alternatives were identified and Alternative 3a was chosen as the preferred due to the fact that it has lower impacts in comparison to other sites as indicated on Figure 6.2 and 6.3 of the Final EIR Report dated April 2010.

- f) The most significant impacts resulting from the proposed project includes potential impacts on sensitive environments and thus the reasons for Alternative 1 and 2 being "No-Go" options.
- g) Visual impacts have been stated as having a marginal difference in the total area calculated of high impact for each alternative.
- h) The anticipated positive impacts resulting from the proposed project includes the upgrade of electricity, the increase in economic activity due to an increase of the number of people in the area with access to personal incomes.
- i) A detailed Public Participation Process was undertaken and the consultant has satisfied the minimum requirements as prescribed in the EIA regulations, 2006 for public involvement.

4. Findings

After consideration of the information and factors listed above, the Department made the following findings -

- The Final EIR dated April 2010 includes the identification, assessment and mitigation of impacts;
- The procedure followed for the impact assessment has been adequate for the decisionmaking process;
- All legal and procedural requirements have been met;
- There has been sufficient consultation with Interested and Affected Parties;
- The information contained in the Final EIR dated April 2010 is accurate and credible;
- Adequate assessment of the main identified issues and impacts have been done;
- The proposed development is compatible with the proposed site for the development; and
- The EMP provided for all identified environmental impacts and includes mitigation measures for the identified impacts and issues.

In view of the above, the Department is satisfied that, subject to compliance with the conditions contained in the Environmental Authorisation, the proposed activity will not conflict with the general objectives of Integrated Environmental Management laid down in Chapter 5 of the National Environmental Management Act, 1998, as amended, and that any potentially detrimental environmental impacts resulting from the proposed activity can be mitigated to acceptable levels. The application is accordingly granted.
