5 December 2012 is the closing date for comments on proposed changes to the cidb Register of Contractors.

The Minister of Public Works has published proposed amendments to the Construction Industry Development (CID) Regulations, 2004 in Government Gazette 35727 on 5 October 2012. The amendments seek to create better alignment of the Register of Contractors with the construction industry and with the state of development of the emerging sector. The public has until 5 December 2012 to comment on the proposed changes.

Comments on the regulation amendments must be submitted to the Department of Public Works via e-mail at gugu.mgwebi@dpw.gov.za or by hand to Central Government Building, cnr Vermeulen and Bosman Streets, Pretoria 0001 or by post to the Department of Public Works, Private Bag X62, Pretoria 0001.

The current regulation amendments are targeted at reducing requirements for registration including: • Removing the requirement for contractors to have registered professionals in their employ • Reducing turnover requirements for Grade 6 and above • Reducing track record requirements for Grades 2 to 9 • Removing Method B • Introducing periodic reviews of tender value range limits.

The draft Regulations also make provision for periodic review of tender value limit at least once every three years.

The Register of Contractors grades and categorises contractors according to their capability to carry out construction projects. In terms of the CID Regulations of 2004, as amended, public sector clients may only award tenders to contractors that are registered with the cidb.
