# Taung testing station reopens

Motorists in the Greater Taung Municipality have celebrated the reopening of their vehicle testing station which has been closed for the past 23 years of the struggle to have their vehicles tested for roadworthiness.

The station which was shut down 1994, was recently renovated, refurbished and upgraded. For the period of struggle, motorists travelled over 70km to Vryburg to access vehicle testing services or travel about 40km to Hartswater, in the neighbouring Northern Cape Province.

Speaking during the official opening of this long awaited Taung Vehicle Testing Station, Community Safety and Transport Management MEC Mpho Motlhabane said the department has noted serious concerns that the non-functioning of the station has not only frustrated car owners, but also the law enforcement officers who could not have suspected un-roadworthy vehicles tested locally. "Today we are not only shortening your journey to Vryburg and

Hartswater but we are cancelling these unnecessary trips. Let us use this testing station effectively in order to ensure that our vehicles are compliant and fit for the road.

"Remember that whenever a vehicle is tested outside the province, Hartswater which is in Northern Cape in this regard, it becomes a loss of revenue to Bokone Bophirima, which is what we are safeguarding. The province needs the skills, infrastructure and personnel to operate this vehicle station, and we do have, by the way," said Motlhabane.

According to the recent systems report, there were about 430 unlicensed motor vehicles around Taung, of which 180 were light-loading vehicles, five heavy-loading vehicles, 17 mini buses as well as 205 light passenger vehicles carrying less than 12 persons.

"These 430 unlicensed vehicles are on our roads on daily basis and as a result, they increase potential accidents and road safety risks. We

therefore humbly request owners of these vehicles to come to this station and test their vehicles," concluded Motlhabane who further appealed to officials employed at the station to be vigilant against individuals attempting to bribe them.

In his response, Batlhaping Ba-Ga Phuduhutswana Chief, Kgosi Tshepo Mankuroane expressed his gratitude and appreciation.

"The opening of this station brings us a great sigh of relief because we have been frustrated for the past years having to cope with the long distances to access these services. We are grateful and we are committing to taking a good care of the facility," he said.

## Ramotshere-Moiloa mayor receives doctorate

The Africa Graduate University has recently honoured the Ramotshere Moiloa Local Municipality Mayor, Cllr Kereng Mothoagae with a Doctorate Degree during the graduation ceremony held at the municipal hall in Zeerust.

Mothoagae was among eleven candidates honoured in different categories for the role they played academically and religiously. She and four others were awarded a Doctorate in Philosophy; one for a Doctorate in Theology, two Diplomats, one Honors graduate, one Masters graduate and one graduate for BA Mass Communication. Africa Graduate University vice-chancellor, Elisabeth Lesomo, recognised the significance to appreciate people for their efforts for them to receive courage for what they were doing.

"We are so honoured to be part of this event to support people in different walks of life being in religion or academic around Africa continent to influence people and appreciate what they have done," she said. Mothoagae was thrilled to be selected as champion graduate to represent other graduates and she expressed gratitude to the Africa Graduate University for recognizing her.

Rendering her first speech as a Doctor, an elated Mothoagae said: "Having been a student and a lecturer before, I know that recognition is not easily awarded, you must sweat in order to be rewarded. Although I am not blowing my own horn as people would always say, I believe that my

"I am grateful to be here today and I am pleased that this function is being held specifically at this around this time when we are celebrating the life of our struggle icon, Oliver Reginald Tambo. If it was not for the likes of Comrade OR Tambo who fought for our freedom, we would not have been able to freely make a positive mark in changing the lives of fellow South Africans. "Having been there myself during the 1976 Soweto uprisings, the name OR Tambo brings precious memories not only for me personally and I believe for every one of you, because I shall never forget that our sacrifices made South Africa to be what it is today".

Mothoagae, who is a registered nurse and lecturer, is the first mayor in Ramotshere Moiloa to be presented with a Doctorate. This was an addition to her other qualifications in Occupational Health, Forensic Science, Psychiatry, Midwifery, to mention a few.


