APPLICATION TO OPERATE THE KOEBERG NUCLEAR POWER STATION (KNPS) BEYOND THE TIMEFRAME ESTABLISHED IN THE NUCLEAR INSTALLATION LICENCE NO. NIL-01 (VARIATION 19)

Your letter k27270N, dated 9 April 2021 as well as the Regulations (No. R.266) on the Long-Term Operation of Nuclear Installations promulgated by the Minister of Mineral Resources and Energy, on 26 March 2021 (LTO Regulations) have reference.

It is noted that the LTO application to operate the Koeberg Nuclear Power Station (KNPS) beyond the timeframe established in the Nuclear Installation Licence No. NIL-01 (Variation 19) was submitted to the National Nuclear Regulator (NNR) before the promulgation of the LTO Regulations. Recognising the importance of compliance with current legislation and standards, Eskom hereby resubmits the updated LTO application.

Eskom applies in accordance with section 21(1) of National Nuclear Regulator Act, 1999 (Act No. 47 of 1999) as well as the Regulations (No. R.266) on the Long-Term Operation of Nuclear Installations, to operate the KNPS beyond 21 July 2024 as specified in Nuclear Installation Licence No. NIL-01 (Variation 19), General Licensing Condition 1.6.

The Eskom application is for a variation to the Nuclear Installation Licence No. NIL-01 to operate the KNPS beyond 21 July 2024 for an additional 20 years, until 21 July 2044 for Unit 1 and 9 November 2045 for Unit 2.

The format of the application is in conformance with Government Notice No.1219 of 21 December 2007 as addressed in section 3.2 of the LTO Regulations. In support of the Eskom application, please find attached the following:
