Ngalokhu kukhishwa isaziso nasi, ukuthi isibawo sokugunyazwa kwezebhoduluko (EA) esikhishwe ngaphasi komthethjhwana ka 2014 Environmental Impact Assessment (EIA) Regulation, nokutjhugululwa kwawo, wamenyezelwa ngekambiso ye National Environmental Management Act, 1988 (Act No. 107 of 1998), nokutjhugululwa kwawo [NEMA] sithunyelwe yi Eskom Holdings SOC Limited (Eskom) mayelana nokwakhiwa kwemihlobo emibili yamadamu mayelana nesakhiwo esiphunyelesiweko se 60 Year Ash Disposal Facility (ADF) nezinye izakhiwo ezikhambelanako. 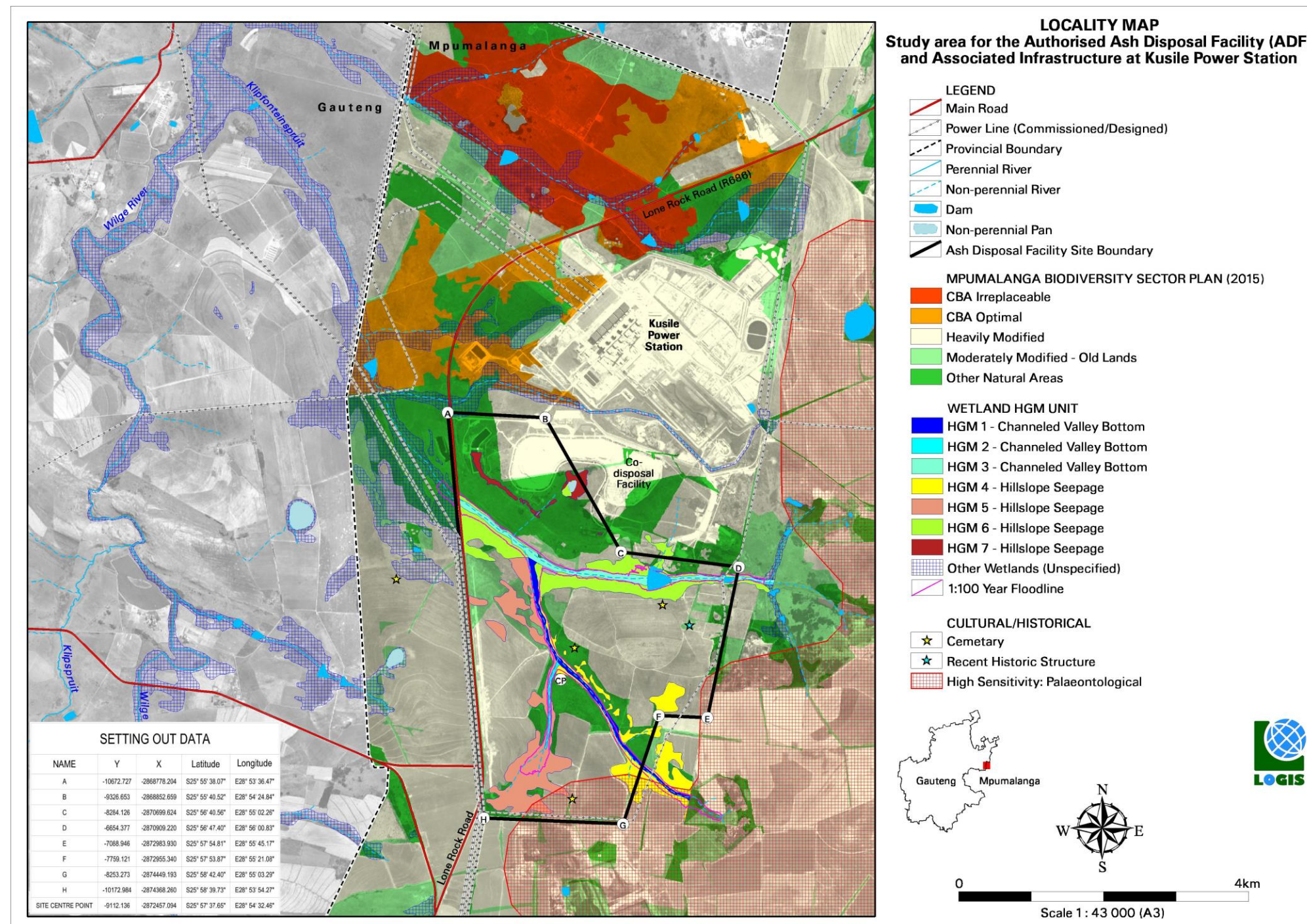
