The current water resources in the Lephalale area had to support all the various developments that were taking place in the area. He is of the opinion that the amount of water that would be stored by the reservoir would impact on other stakeholders, and the size of the reservoir should consider the water balance in the area as a whole.	Department of Water Affairs and Forestry	Public Meeting 26 June 2008	Eskom was in regular contact with these and other stakeholders on this very issue. The issue of water allocations and availability has been raised in previous EIAs undertaken by Eskom for development in the area, and had been considered as part of the EIA process for the Medupi Power Station. This particular project (i.e. the raw water reservoir) is part of the greater power station project that was initially applied for - it is only the position of the reservoir that is changing.
Disadvantaged rural communities are often not represented and that such communities had to have access to water resources.	Mr Ben Sengani Department of Water Affairs and Forestry (DWAF)	Public Meeting 26 June 2008	DWAF had their own separate public participation process to discuss water issues with these communities and Eskom had used the information stemming from the DWAF processes to feed into their (Eskom's) own processes.
The municipality supported development in the area, but certain issues have to be considered within the ambit of the environment. Eskom and the Municipality still had to engage on such issues and suggests that ward councillors should be involved in the process as the representatives of the community. In addition, Eskom has been trying to engage with the Municipality since April 2008 in response to a request from the Municipality in this regard. Eskom would be one of the stakeholders that would be involved in the Municipality's water summit which was to commence on 9 July 2008.
