ENVIRONMENTAL IMPACT ASSESSMENT PHASE

Eskom Holdings Limited is proposing to establish a wind energy facility and associated infrastructure on a site on the West Coast north of the Olifants River. A site of 37 km² has been investigated through an Environmental Impact Assessment (EIA) for the construction of up to 100 wind turbines, a substation and access roads. A route for the Juno-Wind Farm 132 kV power line (~ 40 km in length) has also been investigated.

This project was registered with the National Department of Environmental Affairs and Tourism (Application Reference No. 12/12/20/913) and the Scoping Report submitted in September 2007 was accepted by DEAT.

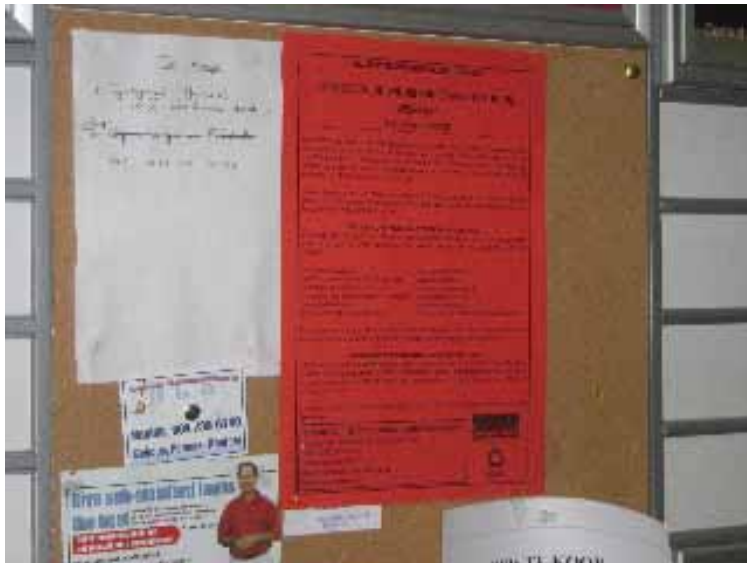

This area comprises the farms Portion 5 of Gravewaterkop 158, and portions of Portions 620 & 617 of Olifants River Settlement.

An area of less than 20km² will be required for the construction of the proposed wind energy facility, and would include up to 100 wind turbines, substation and access roads. A route for the Juno-Wind Farm 132 kV power line (~ 40 km in length) has also been investigated.
