### Notice of Environmental Authorisation Construction of the Dwaalboom 132kV Switching Station and Associated Infrastructure

This serves as notification that the Department of Environmental Affairs (DEA) issued an Environmental Authorisation for the abovementioned project (Reference number 12/12/20/1188) on 16 November 2009 which will take place on the Farm De Paarl 246KP in the Moses Kotane Local Municipality. The aforementioned authorisation is issued in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998), following the undertaking of a Scoping/EIA Process (according to Government Notice No. R.385) for the following activities listed in Government Notice No. R.387:

- 1(i): The construction of facilities or infrastructure, including associated structures or infrastructure for the transmission and distribution of aboveground electricity...
- 2: Any development activity, including associated structures and infrastructure, where the total area of the developed area is, or is intended to be, 20 hectares or more.

As well as the following listed activities in Govt. Notice No. R386:

- 7 : The aboveground storage of a dangerous good...
- 12 : The transformation or removal of indigenous vegetation of 3ha or more...
- 14 : The construction of masts of any material or type or any height...
- 15 : The construction of a road that is wider than 4m or that has a reserve wider than 6m...
- 16(a): The transformation of undeveloped, vacant or derelict land...
