The Department of Environmental Affairs has issued the Environmental Authorisation (Reference DEAT/NEAS/5942/2009) for the proposed construction of Ngwedi (Mogwase) substation and associated lines in terms of the National Environmental Management Act, 1998: GN R.387 and the Environmental Impact Assessment Regulations, subject to conditions included in the Environmental Authorisation.

1. Chapter 7 of the Regulations stipulates that a Notice of Intent to Appeal must be lodged with the Minister within 20 (twenty) days from the date on which the Authorisation was issued to the applicant as per GN R.542 of 2010
2. After having submitted your notice of intention to appeal to the Minister, provide the applicant with a copy of the notice of intention to appeal within 10 days of lodging the notice.
3. The Applicant must also serve on the Applicant within 10 days of lodging the notice, indicating where and for what period the appeal submission will be available for inspection by the applicant.
4. The applicant must be submitted to the Minister within 30 days after lapsing of the 20 days provided for the lodging of the notice of intention to appeal
5. An applicant who received notice of intention may submit a responding statement to the appeal to the Minister within 30 days from the date that the appeal submission was lodged with the Minister
