The Environmental Impact Assessment (EIA) process advertised during April 2013 whereby notice was given that Eskom Holdings SOC Limited proposes to develop a new 400/132kV substation (called Weskusfleur) in the vicinity of the existing Koeberg power station in the Western Cape Province is now continuing.

### REVIEW OF FINAL ENVIRONMENTAL SCOPING REPORT

Due to restrictions placed on any further development around Koeberg Power Station the EIA process was placed on hold. The Final Scoping Report (FSR) was already out for public comment during late 2013 and submitted but was rejected by the Department due to these development restrictions. Eskom has now successfully complied and the restrictions were lifted. The EIA process can therefore continue. (Still under Government notice, R544, R545 and R546, of 18 June 2010) The same FSR plus proof of compliance by Eskom is now available for public comment.
